Knowing these facts, I nevertheless in consideration of your acceptance of this form, hereby for myself, my heirs, executors and administrators waive, release, discharge and hold harmless, Mary Rose Anderson, MR Anderson Horsemanship, TNT Ranch at 4287 Corona Ave. Norco, California, it's owners, teachers, and all individual members thereof and all other persons and organizations in any way connection with events, property, boarding, lessons, shows, clinics or any other activity associated herewith, their representatives, heirs, executors, administrators, and assignees, from any and all claims of any and all right claims or liability for damages, or for any and all claims of any kind or nature that I might have as a result of or arising out of my participation in any activity at location of 4287 Corona Ave. Norco, California.

## Barn Rules

1. Respect hours of operation: 7:00am-9:00pm. The main gate will be closed after hours and open during normal hours. If the gates are closed during operation hours, please close the gate behind you when going through.
2. No speeding in the driveway! Please keep a 5pm speed limit and watch for others.
3. Park in designated parking locations only. Do NOT block any horse trailers.
4. All visitors must sign a release form before conducting any ranch activities.
5. No horseplay at the barn! This includes running, shouting, throwing objects, waving objects, and fighting.
6. Never pet or feed a horse you do not know, ask permission.
7. All children must be supervised.
8. Riders 18 years and under must use an ASTM/SEI certified helmet.
9. Riders are required to wear riding boots with heal. Visitors and guests are required to wear closed toe shoes.
10. No Smoking.
11. Dogs must be on a leash, and owners are responsible for cleaning up any mess and poop afterwards.
12. Clean up any manure left by your horse. This includes in the driveway, parking lot, by trailers, at tacking stations, wash racks, and in the round pen, pasture, warm up arena and main arena.
13. Visiting farriers must pick up after themselves and that includes using a magnet to pick up any metal. Shoes must be disposed of in the trash cans and not in the manure buckets.
14. Please do not leave your horse unattended in the round pen, pasture and warm up arena. And limit 15 minutes time when others are waiting in line.
15. The main arena is for lunging and riding only. No turning out!
16. Use trash cans placed around the barn to throw away any trash.
17. Make sure to turn off all water valves and never walk away from a running hose! Hoses must be rolled or coiled back up after every use.
18. Horse owners are responsible for cleaning loose hay in and around their stalls.
19. Only put manure and hay in the manure bin and only add extra stall cleaning waste on Mondays-Thursdays.
20. Close all gates and stall doors.
21. If you open it, close it.
22. If you turn it on, turn it off.
23. If you don't know something, ask.
24. Don't use others' property.
25. If you take something out, please put it back.
26. No drama!
27. Have fun!
